If you're a paid preparer, enter your Preparer Tax Identification Number (PTIN) in the space provided. Include your complete address. If you work for a firm, enter the firm's name and the EIN of the firm. Instructions for Form 7200 (03/2020) | Internal Revenue ... Form 1040 or 1040-SR (2019), lines 1-7b (includes Schedule 1, lines 1-9). However, do not include any income shown on these lines from Form(s) W-2. In columns (b) and (c), allocate joint income, such as interest earned on a joint bank account, as you

To file a protective claim for tax year 2016, taxpayers make sure their claim is properly addressed, mailed, and postmarked by July 15, 2020. Generally, the taxpayer must file their claim for a credit or refund within 3 years after the date they filed their original return or within 2 years after the date they paid the tax, whichever is later. Due Date to File a Protective Claim for Tax Year 2016 ... Claim Filing Instructions and Forms. You must file a claim with the State Controller's Office. If your claim is eligible, you will be given the option to file electronically after you have entered the requested information for your claim.
