Ordinary Resolution for Removal of Director under Section 169 A special notice shall be required of any resolution, to remove a director under the said section, or to appoint somebody in place of a director so removed, at the meeting at

which he is removed. Further refer section 115 of the Companies Act and rule 23 of the Companies (Management and Administration) Rules, 2014 to know in detail the provisions regarding special notice.
